1. Call to Order/Quorum

2. Approval of Minutes

3. Presidents Report

We have 3 teams that did not have Safety People registered. 3 younger teams have been fined each \$100 for not registering safety people. The question is should association pay or teams. There were some difficulties with teams getting the safety, part to do with website and tracking and part in reformation of teams. Emails were not reaching proper people to complete the tasks. Some things were lost with manager meetings being via zoom. Need to look at processes and how things are tracked, difficult with system.

Motion put forward by Steph to cover cost of fines of \$100 per team for the 3 teams if we can not get fines reversed. 2nd by Marvin. All in favour. (will try to resolve fines if not the association will pay)

Parents may choose to bring their athlete(s) dressed in their hockey gear. Parents may also use the main lobby area to tie skates and put on hockey gear"
