PMAHA was approached by the manager of the Coquitlam Sharks Hockey Team, a team of players ranging from 8-18 years old. The team was formed as part of the Canucks Autism Network (CAN), with the goal of offering the opportunity to play hockey to kids on the autism spectrum. There are now 6 teams in the lower mainland. Teams are currently practicing, but due to difficulty securing ice, they are not getting the chance to play games on a regular basis. The Sharks are asking PMAHA to partner with their club, so they could have a home base for many years to come. In return, they are committed never to increase past 8 total ice times during the regular season. They will obtain insurance and pay for the ice time.

Motion: A motion was made by Steph Naqvi to provide the Coquitlam Sharks Hockey Team one ice time per month during the regular season, for a total of 8 ice times, so they can play games. The motion was seconded by Sean Postle and was approved unanimously.
